Previously, Frank Heemskerk was member of the Managing Board of Royal HaskoningDHV,

an engineering and project management consultancy with 7,000 staff members and 100

offices worldwide.

Preceding this position, he served from 2007 to 2010 as Minister for Foreign Trade of the

Netherlands. During this period, he was also responsible for the Post, Telecom, ICT,

Consumer Policy and Tourism.

From 2003 to 2006, he was member of the House of Representatives of the Netherlands for

the PvdA (Labour Party).

He started his career at ABN AMRO Bank in 1995 and then held various positions.

Frank Heemskerk graduated in 1994 from the University of Amsterdam, faculty of Economics

and was an Erasmus student at KU Leuven.

As of November 2018, he will be a visiting lecturer in Geo-Economics at Leiden University,

faculty of Governance and Global Affairs.
